### ELIGIBILITY FOR CLASSES

**Encourage** - For **handlers** who have won no more than three Encourage trials.

An Encourage handler may win 3 encourage class trials.

An encourage handler may win 2 encourage class trials with dogs that have won trials that are of a higher class .

**Maiden** - For **dogs** that have never won a Yard dog trial except an Encourage trial.

A maiden dog may be nominated in a novice class on the day at the discretion of the convener. Both fees must be paid.

**Novice** - Dogs that have won no more than two novice trials. A novice dog may be nominated in an improver class provided it has won at least one novice class trial and at the discretion of the convener. Both fees must be paid.

**Improver** - Dogs that have won 2 novice trials but not an open trial. Dogs may be nominated in both the improver & open trial. Both fees must be paid.

**Open** - Dogs that have won their novice & improver classes.

*All affiliated trials will be conducted in accordance with the rules & regulations of the SAYDA Inc.*
