Transport of dogs: Dogs are not to be over crowded in vehicles and trailers. Dogs are to be safely secured when being transported. Trailers & cages transporting dogs are to be kept clean & well ventilated with water to be regularly offered to dogs. 3. Behaviour of handlers and members: Handlers disciplining dogs in a manner that offends the public will not be tolerated at SAYDA Inc venues and events. Handlers disciplining dogs on the trial ground will be reprimanded, have points deducted or be disqualified. Handlers & members must not inflict pain or cause wilful distress to any animal. Handlers & members are required to be respectful towards officials, other members, handlers & spectators & behave in a sportsmanlik manner both on & off the trial venue.
